We wish to remind members of Article 21 of the Kennel Union Constitution:-

 ${\tt JURISDICTION\ OF\ KENNEL\ UNION\ -}\ {\it Every\ person}$ 

- (a) making application to the Kennel Union for the registration, recording or transfer of a dog or the registration of an affix;
- (b) entering, exhibiting or handling a dog at a Show or other event held under Kennel Union licence:
- (c) taking part in, officiating or judging at a Show held under Kennel Union licence;
- (d) holding membership of the Kennel Union;
- (e) holding membership of any Club affiliated to the Kennel Union; shall be deemed thereby to have submitted to and agreed to be bound by this Constitution and all Schedules, with particular reference to Schedule 9, Code of Ethics, Rules, Regulations and By-Laws framed there under, both in respect of himself and in respect of every dog owned by him, registered or recorded in his name or owned, registered or recorded by him jointly with another or others or owned or registered or recorded in the name of a nominee, or exhibited or handled by him.
